- Able to take calls on a rotating basis with a 20 minute response time frame
- Provide radiation protection for patients and fellow employees following the ALARA principal
- Demonstrate anatomy requested per examination adhering to department examination protocols and standards of care
- Is knowledgeable in the use of intravenous contrast media and how to recognize adverse reactions
- Prepare completed images for reading by interpreting physician or the interpreting radiologist
- Perform other departmental duties including, but not limited to; scheduling appointments, answering the phone, transporting patients, restocking and cleaning
- Transfer patients in a safe manner
- Review patient history and interpret the information to evaluate the appropriateness of the exam ordered
- Able to perform venipuncture on patients receiving intravenous contrast media
- Ability to access the patient's lab values indicating renal function and follow the facility's policy on the safe administration of contrast media
- Perform all functions according to established policies, procedures and regulatory requirements, as well as professional standards
