Communicates treatment plans and patient teaching in accordance with established protocols. Collects and assesses significant patient history information and performs all necessary patient teaching.

- Coordinates patient services between departments within and outside the facility.
- Participates in applicable quality improvement endeavors
- Provide hands on patient care
- Report significant changes in patients' medical condition to provider promptly and accurately
- Document, review and modify patient current medications, under Doctors orders
- Administer routine vaccines, allergy shots and nebulizer treatments, medications, providing orders for refilling routine medication and providers review of controlled substances
